<b>Skin contact</b>	Wash off with soap and water. Get medical attention if irritation develops and persists.

## 5. Fire-fighting measures

## 6. Accidental release measures

## 7. Handling and storage

<b>Precautions for safe handling</b>	Minimize dust generation and accumulation. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Provide adequate precautions, such as electrical grounding and bonding, or inert atmospheres. Explosion proof exhaust ventilation is recommended. Wear appropriate personal protective equipment. Observe good industrial hygiene practices. Avoid prolonged exposure.
<b>Conditions for safe storage, including any incompatibilities</b>	Keep containers tightly closed in a dry, cool and well-ventilated place. Store away from incompatible materials (see Section 10 of the MSDS). Keep away from heat, sparks and open flame.

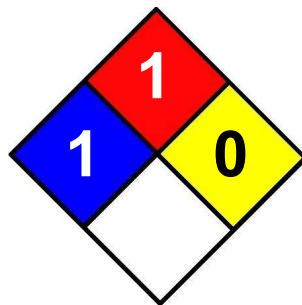
